### Were the Founding Fathers of the United States Buddhist? J.K. Hirano

Religion. Your reason is now mature enough to examine this object. In the first place, divest yourself of all bias in favor of novelty & singularity of opinion. Indulge them in any other subject rather than that of religion. It is too important, and the consequences of error may be too serious. On the other hand, shake off all the fears & servile prejudices, under which weak minds are servilely crouched. Fix reason firmly in her seat, and call to her tribunal every fact, every opinion. Question with boldness even the existence of a God; because, if there be one, he must more approve of the homage of reason, than that of blindfolded fear. You will naturally examine first, the religion of your own country. Read the Bible, then as you would read Livy or Tacitus. The facts which are within the ordinary course of nature, you will believe on the authority of the writer, as you do those of the same kind in Livy & Tacitus. The testimony of the writer weighs in their favor, in one scale, and their not being against the laws of nature, does not weigh against them. But those facts in the Bible which contradict the laws of nature, must be examined with more care, and under a variety of faces. Here you must recur to the pretensions of the writer to inspiration from God. Examine upon what evidence his pretensions are founded, and whether that evidence is so strong, as that its falsehood would be more improbable than a change in the laws of nature, in the case he relates. For example, in the book of Joshua, we are told, the sun stood still several hours. Were we to read that fact in Livy or Tacitus, we should class it with their showers of blood, speaking of statues, beasts, &c. But it is said, that the writer of that book was inspired. Examine, therefore, candidly, what evidence there is of his having been inspired. The pretension is entitled to your inquiry, because millions believe it. On the other hand, you are astronomer enough to know how contrary it is to the law of nature that a body revolving on its axis, as the earth does, should have stopped, should not, by that sudden stoppage, have prostrated animals, trees, buildings, and should after a certain time gave resumed its revolution, & that without a second general prostration. Is this arrest of the earth's motion, or the evidence which affirms it, most within the law of probabilities? You will next read the New Testament. It is the history of a personage called Jesus. Keep in your eye the opposite pretensions: 1, of those who say he was begotten by God, born of a virgin, suspended & reversed the laws of nature at will, & ascended bodily into heaven; and 2, of those who say he was a man of illegitimate birth, of a benevolent heart, enthusiastic mind, who set out without pretensions to divinity, ended in believing them, and was punished capitally for sedition, by being gibbeted, according to the Roman law, which punished the first commission of that offence by whipping, & the second by exile, or death in fureâ. See this law in the Digest Lib. 48. tit. 19. §. 28. 3. & Lipsius Lib 2. de cruce. cap. 2. These questions are examined in the books I have mentioned under the head of religion, & several others. They will assist you in your inquiries, but keep your reason firmly on the watch in reading them all.

Do not be frightened from this inquiry by any fear of its consequences. If it ends in a belief that there is no God, you will find incitements to virtue in the comfort and pleasantness you feel in its exercise, and the love of others which it will procure you. If you find reason to believe there is a God, a consciousness that you are acting under his eye, & that he approves you, will be a vast additional incitement; if that there be a future

state, the hope of a happy existence in that increases the appetite to deserve it; if that Jesus was also a God, you will be comforted by a belief of his aid and love. In fine, I repeat, you must lay aside all prejudice on both sides, and neither believe nor reject anything, because any other persons, or description of persons, have rejected or believed it. Your own reason is the only oracle given you by heaven, and you are answerable, not for the rightness, but uprightness of the decision. I forgot to observe, when speaking of the New Testament, that you should read all the histories of Christ, as well of those whom a council of ecclesiastics have decided for us, to be Pseudo-evangelists, as those they named Evangelists. Because these Pseudo-evangelists pretended to inspiration, as much as the others, and you are to judge their pretensions by your own reason, and not by the reason of those ecclesiastics. Most of these are lost. There are some, however, still extant, collected by Fabricius, which I will endeavor to get & send you.

#### Excerpt from Thomas Jefferson's letter to his nephew Peter Carr, 1787

I was standing with the crowd as the "Pledge of Allegiance" was recited at one of the High School volleyball games for Kacie. Carmela looked at me and said, "one nation under God?" I have never really had a problem stating that phrase. I am of the belief that under certain circumstances, as a Jodo Shinshu Buddhist, to paraphrase Rennyo, "One should keep the king's law on your sleeve, but Buddha's law in your heart." My saying, "one nation under God" does not change who and what I am. It's kind of like the questions I felt as a member of the local boy scout troop when they said, "Duty to God and my country." The Buddhist Churches of America has had Boy Scout troops since the 1920s. Yet the Boy Scouts of America state:

Declaration of Religious Principle. The Boy Scouts of America maintains that no member can grow into the best kind of citizen without recognizing an obligation to God. In the first part of the Scout Oath or Promise the mbmer declares, "On my honour I will do my best to do my duty to God and my country and to obey the Scout Law." The recognition of God as the ruling and leading power in the universe and the grateful acknowledgment of his favours and blessings are necessary to the best type of citizenship and are wholesome precepts in the education of the growing members.

#### Duty to God. BSA Legal Issues, Boy Scouts of America

I have long believed that the Boy Scouts provided me and provide many thousands of young men wonderful experiences that can benefit their lives in many ways. As a Buddhist, since I had chosen to be a member of the boy scouts, it was my responsibility to show the Boy Scouts of America that as a Buddhist, I can be the best kind of citizen, without the belief in your God. The bottom line for the use of these terms is that they are voluntary actions on my part. I choose to be an American citizen and I chose to be a scout. There was no forced involvement on the part of the government or Boy Scouts of America in my joining either.

I know that there are those who make accusations that Christian beliefs or the act of believing in God are wrong. I am currently reading a couple of books by Richard Dawkins a celebrated atheist, where he points out the problems in a belief in God. In fact, that is where I first read about Jefferson's letter to his nephew. However, I would rather turn to what the Buddha taught in his Kalamas Sutra.

"Now, Kalamas, don't go by reports, by legends, by traditions, by scripture, by logical conjecture, by inference, by analogies, by agreement through pondering views, by probability, or by the thought, 'This contemplative is our teacher.' When you know for yourselves that, 'These qualities are skillful; these qualities are blameless; these qualities are praised by the wise; these qualities, when adopted and carried out, lead to welfare & happiness'-then you should enter and remain in them.

If Thomas Jefferson had the means to read the Kalama Sutra, he might have quoted it to his nephew.

One of the most important teachings in Buddhism is that all things are constantly changing. There is a section in the book, <u>The God Delusion</u> by Richard Dawkins where in talking about the journalist Robert Sherman's report of a meeting with George Bush Sr. he writes, "when Sherman asked him whether he recognized the equal citizenship and patriotism of Americans who are atheists: 'No, I don't know that atheists should be considered as citizens, nor should they be considered patriots. This is one nation under God." I'm curious if our former president had ever read Thomas Jefferson. However, we have now rid our county for the present moment of the Bushes and have elected President Barack Obama.

I personally believe that in reciting the Pledge of Allegiance or the Scout Oath, I was not betraying my Buddhist beliefs. For the most part, this country I was born in and am a citizen of, and the scout troop I was a member of did not and does not try to purposefully inflict harm on others without justification. I do believe that the beliefs of our founding fathers such as Jefferson, Franklin, Madison, who are often referred to as Deists, if alive would currently be considered Buddhist. Namo Amida Butsu
